



## Privacy Policy

Bangladesh ECD Network (BEN) ("we", "our", or "us") operates the website [www.ecd-bangladesh.net](http://www.ecd-bangladesh.net) (the "Site"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our Site.

### 1. Information We Collect

We may collect the following types of information:

- Business Transfers: In connection with a merger, sale, or acquisition.
- We do not sell your personal information.
